

(5) **“Sustainable Animal Production and Resource Management for Sustainable Agriculture and Food Safety”** to be organised in Thailand by Khon Kaen University during 18 June – 13 July 2018 with a closing date for application on 16 March 2018. (Attachment 5).

(6) **“Modern Technology for Sustainable Agriculture Systems (MoTSAS)”** to be organised in Thailand by Naresuan University during 19 June – 5 July 2018 with a closing date for application on 16 March 2018. (Attachment 6).

Successful candidates from the AITC eligible countries/territories will be offered international economy air ticket, accommodation, allowance, travel programme, insurance and airport meeting service during the period of training in Thailand.

**TICA : Thailand International Cooperation Agency** is a national focal point for Thailand's international development cooperation. **International Training Center on AIDS, TB and STIs, Department of Disease Control, Ministry of Public Health**

International Training Center on AIDS, TB and STIs was established in 2004 to conduct international training courses on AIDS, TB and STIs, one of the most pressing international health agendas. ### Focus - Objectives

This training course aims at sharing Thailand's experiences in implementing Antiretroviral Treatment (ART) programme in tackling with HIV/AIDS problem. At the end of this course, participants are expected to;

- Understand principles and concepts of Antiretroviral Treatment (ART) management and long-term adherence to ART.
- Understand how the ART program can be sustained by including in the Universal Health Coverage scheme.
- Be able to develop strategies and methodology in implementing ART programme including monitoring and evaluation.
- Be able to apply knowledge and skill gained to the case of their respective countries.

### Course Methodology

Training methodologies to be used during this training course include;

- Lecture
- Group discussion
- After action review (AAR)
- Study visit
- Demonstration

### Assignment and Evaluation

- In-class participation and discussion.
- Advance assignment - Submission and 10-minutes presentation of "Country Report" which contains information on national HIV/AIDS and ART programme of their respective countries that include, such as relevant epidemiology/ policy, health services system, counseling and testing services, care service, M&E System and Community participation
- Attendance - Participants are required to attend all activities organized during the course. TICA reserves the rights to revoke its fellowship offered or take appropriate action in case a participant is in attendance of less than 90 percent of the training hours.

### Course Outline

This training course offers knowledge and understanding on the management of Antiretroviral Treatment (ART) programme and Long-term Adherence to ART. Topics of training are such as;

- Overview of Global and National AIDS Program
- Updated Knowledge on HIV Infection and Antiretroviral Treatment
- Drug Resistance
- Components of Service Delivery in Ending AIDS Program and ART Program
- National HIV/AIDS Program Management and Service Packages
- HIV Counseling and Testing Services
- Stigma and Discrimination
- Adherence to ART
- Financing and Access to Affordable ART
- ART Program Monitoring and Evaluation
- Sustainability of ART Program

### Participant Criteria

Candidates must possess qualifications as specified in "Guideline for Thailand's Annual International Training Course Programme" No. 2 "Qualifications" as well as following qualifications;

- Two candidates must be nominated per country. One person should work in national ART programmes/policies and another person should work in relevant local healthcare centre.
- Currently working with at least two-year experience as Health official of medical, nursing or public health officers in the treatment and care for PLHA and well conversant on the HIV/AIDS program of own country.
- Age between 27 - 50 years of age

## Application

- Candidates must be nominated from their country. One person should work in national ART programmes/policies and another person should work in relevant local healthcare centre.

Candidates must be nominated/ endorsed by their respective governments of the eligible countries/territories by the closing date for application.

- Complete nomination documents must be submitted to TICA through the Royal Thai Embassy/ Permanent Mission of Thailand to the United Nations/Royal Thai Consulate-General accredited to eligible countries/ territories.
