The People's Republic of Bangladesh has received a Credit from the International Development Association towards the cost of Health, Population and Nutrition Sector Development Program (HPNSDP) and intends to apply part of the funds to cover eligible payments under the Contract for Operational and Technical Support to the Program Management and Monitoring Unit (PMMU). Priced Offer submission is open to all offerers from eligible source countries as defined in the Guidelines: Procurement under IBRD Loans and IDA Credits.

The Ministry of Health and Family Welfare (MOHFW) of the Government of the People's Republic of Bangladesh hereby invites sealed Priced Proposal from the eligible firms for providing operational and technical assistance to the PMMU for procurement, personnel and logistics management, capacity development and advisory services, the details of which are provided in Appendix-A of the Priced Proposal documents.
3. Key qualification criteria and other requirements could be found in the priced proposal document. A complete set of Priced Proposal Documents (hard copy) in English may be purchased upon payment of a non-refundable fee of Bangladesh Taka (BDT) 500 (five hundred only) in cash from the Program Management and Monitoring Unit (PMMU), 2<sup>nd</sup> floor, Old Janashankha Bhaban, Azimpur, Dhaka-1205 (adjacent to Azimpur Maternity clinic), Telephone no. 9665313-14, from 10.00 am to 4.00 pm during regular working days (from Sunday through Thursday except government holidays). Interested offerors have to buy the hard copy of the Priced Proposal document. Electronic proposal submission is not allowed.

5. Proposal must be delivered to the PMMU office (address as mentioned above) at or before 2.00pm local time on 26 December 2013. Late proposal will be rejected. Priced proposal will be opened in the presence of offerors/ representatives who choose to attend in the PMMU office at 3.00 pm on 26 December, 2013.



6. The Priced Proposal shall be valid for a period of 60 days after the deadline for Priced Proposal submission specified in the priced proposal data sheet (PPDS). The authority reserves the right to accept or reject any or all the offers without showing any reasons whatsoever.
