
Government Order

Saleh Uddin, Secretary in Charge, Medical Education & Family Welfare Division, Ministry of Health & Family Welfare will be accompanied by his wife Ms. Ayesha Nargis, daughters Anika Tasrin Seouti & Nabila Amrin Sejuti. During returning from Indonesia he will stay in Singapore along with his wife and two daughters for two days and will return back to Bangladesh as per schedule. All expenses related to his wife & two daughters will be borne by himself.
 - f. During returning from Indonesia Mr. Momin Uddin, Senior Assistant Secretary, Medical Education & Family Welfare Division, Ministry of Health and Family Welfare will stay in Singapore for two days and will return back to Bangladesh as per schedule.
