- c. During the period of their service under the foreign employer they will not receive any pay or allowances (including travelling allowances, etc.) or leave from the Government of the People's Republic of Bangladesh.
- d. The terms of their leave during the period of their service with the foreign employer will be regulated according to the rules of the foreign employer and the leave salary due in respect of such leave will be payable by the employer. No Liability in respect of leave salary on account of such leave earned or taken during foreign employment shall devolve on the Government of the People's Republic of Bangladesh or any organization under it. **The Government of the People's Republic of Bangladesh will not recover any leave salary contribution from the foreign employer.**
- e. All expenses to be incurred in connection with their joining the post under the foreign employer and for resuming their posts in Bangladesh after completion of the period of Foreign Service will be borne either by the foreign employer or by them self. 

They will vacate the Government house within 6(six) months of the beginning of foreign service if they are residing in a Government hired house or Government allotted house before joining the service and will pay the house rent for the said 6(six) months as usual rate.
